



## **SUMMARY of ACHIEVEMENTS**

**Glenn Sinclair has achieved leadership in the field of *moral reasoning and the resolution of ethical dilemmas* in the decision-making process: Extending the work of Kohlberg and Mosher into a unique focus on the development of ethical-reasoning skills in adults re: how to resolve the critical decisions of management where moral conflict can arise. Preparation for the Doctor of Philosophy degree from the University of Alberta (1978) resulted in the thesis *The Development of a Program in Moral Reasoning for Educational Administrators*. This program has been offered to educators at the Universities of Alberta, Saskatchewan and Victoria plus Concordia University College of Alberta, and has been adapted for use by numerous levels of leadership personnel in the private, public and not-for-profit sectors.**

**In association with the late Dr. Howard Gillies of *Foresight 20/20*, Dr. Sinclair developed an effective approach to strategic planning and thinking which has been successfully adapted to facilitating conflict resolution and mediation-related challenges re workplace environment enhancement as well as in *faith* organizations.**

**Dr. Sinclair has been a leader in the development of *Independent Schools* within Aboriginal communities as an avenue towards greater Indian ownership and control of Aboriginal educational processes. Dr. Sinclair has developed special expertise and approaches in the fields of Aboriginal Education and Aboriginal Management Training including particular skills in resource acquisition and system design.**

**In the area of gaining effective community input to key decisions, The *Sinclair Model for Public Involvement in the Planning Process* has been thoroughly developed and proven. Adaptable to all planning processes, it provides politicians and bureaucrats alike access to useful skills to provide dynamic leadership on public involvement and community participation. Training workshops plus on-site consultative leadership and/or advice can be delivered effectively by Dr. Sinclair.**

**Dr. Sinclair developed a management model for more effective organizational response to local/community input to service delivery. Known as the *inverted pyramid*, the model was implemented in the newly created Child & Family Services Authority #12 (*Sakaigun Asky*) in Northeastern Alberta. Preliminary results indicated that it is successful at empowering front line workers while simultaneously strengthening the Board governance model.**

**The Educators' Program Package produced for the Salmonid Enhancement Program and approved by B.C. Ministry of Education has been in use in B.C. schools now for over thirty-five [35] years under the title *Salmonids in the Classroom*. The high calibre of this package generated enthusiastic response from many sources within the educational and resources sectors thus awarding it a landmark position in resource management education..**

**Dr. Sinclair has also done the design phase plus preliminary research on the more comprehensive curriculum project: *Renewable Resources Management Education (RRME)*. This concept, tested out in a variety of contexts, particularly at Mestanta Technological Institute, would provide a new approach to high school education combining hands on and academic learning experiences towards a development of a more entrepreneurial and/or trainable student.**

**Glenn Sinclair is a personable speaker, accustomed to and comfortable in conduct of workshops, seminars, public inquiries, and meetings. He has taught students from the junior secondary to the post-graduate level and frequently is a guest speaker/lecturer at public and private business seminars and service luncheons. Experience in the public, private and not-for-profit sectors has provided a familiarity with governments at all three major levels as well as with large and small corporations and not-for-profit organizations.**
